## SCHOLARSHIP APPLICATION

---

Peoples Bank and Fleetwood Insurance Group have established a scholarship program for graduating seniors of Kent, Queen Anne's and Talbot Counties. We have allocated \$6,000 (six thousand dollars) to fund a yearly scholarship program. These funds will be awarded to a graduating senior(s) from all three counties, to be paid directly to student's institution of higher education upon notification of enrollment.

Eligibility requirement:

- Interested candidate should know that emphasis will be placed on extra-curricular activities and community involvement
- Applicant must have a minimum GPA of 2.5 (copy of transcript required with application)
- Applicant must be a graduating senior in either Kent, Queen Anne's or Talbot Counties
- Applicant has been accepted into an institution of higher education; University, College, Vocational, or Trade School, (copy of letter of acceptance required with application)
- **Submission of two-page essay answering the following question:  
What makes a good leader? Who is an example of an excellent leader, from history or present day, and why?**
- Completed application received by May 1<sup>st</sup> of each academic year

Program is designed to recognize the youth of our counties and encourage continued education as self-improvement. While there are no forward obligation requirements under the program as to residency, it is hoped that it will support the continuing education desires for graduating seniors living here and desiring to make a life in our communities. In evaluating applications, the committee members will consider educational success to date in school, service to community, involvement in outside activities, applicant's goals and aspirations, financial need, and essay response.

Scholarship award is currently excluded from taxable income, however must be used exclusively for qualified tuition and related expenses, which are (1) tuition and fees required for enrollment or attendance at a qualified educational organization, and (2) fees, books, supplies and equipment required for courses of instruction at such an organization.

**Recipients are responsible for providing contact and payment information on awarding of the scholarship.**
